Thank you for your interest in joining the Riding Club of Barrington Hills (RCBH). We are an all volunteer, social riding organization formed in 1937. The RCBH seeks to maintain the old tradition of neighbors riding to visit neighbors, and is dedicated to preserving, expanding and riding the bridle paths in Barrington Hills. 1. Applicant must be a resident of Barrington Hills, or within hacking distance of the bridle path system.
2. Applicant owns a horse stabled in Barrington Hills.
3. Applicant is a member of the FRV Hunt or the FRV Pony Club.

Private Trail Rules

It is with the permission of our landowners and the existence of prescriptive and historic trail easements that we enjoy an extensive private trail system in Barrington Hills. If our landowners' property is misused, trails will be closed to us. Please follow the guidelines of the RCBH to insure that our bridle paths will continue to be viable. We rely on volunteers to help us maintain our trail system: please report missing trail markers and obstructed trails to your trail reps (listed on the first page of the directory), and please consider donating your time on designated trail clean-up days.

Rules for Private Trail Usage:

- You must be a RCBH member to ride the private trails
- Members must accompany their guests when riding on the private trails. Guests should sign a release and waiver of liability located on the second page of the application.
- Follow the green and red RCBH trail markers. Please clean up manure left on private driveways.
- Members are responsible for any damage done by their horse; don't ride on lawns when muddy.
- No galloping. Observe posted signs to walk, trot or single file
- Current RCBH tags should be attached to your saddle. The Forest Preserve District of Cook County requires an Annual Private Horse License for riders and horses using Cook County Forest Preserve property. Call (708) 771-1057 for an application.
- Please do not litter. No smoking.
- Bridle paths are for horses and riders only. No motorized vehicles or dogs allowed.

IT IS UNDERSTOOD THAT THE BRIDLE PATHS ARE PRIVATELY OWNED, MAINTAINED BY THE RIDING CLUB OF BARRINGTON HILLS, & ARE ONLY FOR THE USE OF RCBH MEMBERS IN GOOD STANDING. ABUSE OF PROPERTY OR DISRESPECT TO A LANDOWNER MAY RESULT IN LOSS OF TRAIL PRIVILEGES. NON-MEMBERS USING THE PRIVATE RCBH BRIDLE PATHS ARE GUILTY OF TRESPASSING.
